A longtime disability rights champion, Katherine "Katy" Neas comes to The Arc from the U.S. Department of Education, where she served as deputy assistant secretary in the Office of Special Education and Rehabilitative Services. Prior to that role, she was executive vice president of public affairs for Easterseals and the American Physical Therapy Association (APTA). She is widely regarded for her bipartisan and collaborative work, earning her roles including past chair of the Consortium for Constituents with Disabilities (CCD).



Katy shared, "Stepping into this role as CEO of The Arc feels like coming home. Throughout my career, I've been lucky to work arm-in-arm with fierce advocates and caring providers to drive progress. That open collaboration and trust is what makes The Arc so special—never losing sight that we do this WITH people with disabilities, not just FOR them. Medicaid Waiver Changes

The Family and Social Services Administration has submitted waiver amendments for proposed Pathways for Aging, Health and Wellness (H&W), Traumatic Brain Injury (TBI), Community Integration and Habilitation (CIH), and Family Supports (FSW) Waivers. A concerning proposal would stop the practice of reimbursing parents of a minor child for providing attendant care to medically fragile children through the Health and Wellness, (formerly A&D Waiver) and TBI Waivers. They would be required to shift to a service called Structured Family Caregiving, at a lower rate, use a family member who is not an LRI, or use an attendant placed through an agency.

We have created a <u>2024 Medicaid Waiver Changes</u> page on our website to provide clarity and share information. It includes information on submitting public comments by the February 16 deadline and a Call to Action.

Lt. Governor Suzanne Crouch has called on FSSA to pause implementation of this change and has called on the General Assembly to address this issue. We appreciate the Lt. Governor's advocacy as well as the support of many legislators.

We are very concerned that this proposal will harm medically fragile children. We continue to work with FSSA, state leaders and legislators to identify solutions that do not harm people with disabilities and their families.



Report from the Statehouse



The 2024 session of the Indiana General Assembly began January 8 and must end by March 14. We have been there every day, supporting and monitoring legislation impacting people with intellectual and developmental disabilities and their families. As the session reaches its halfway point, we are pleased to report success with two of our priority bills.

House Bill 1073 - Special Education, Regarding Seclusion and Restraint in Schools

Passed the House 73-24. Among other provisions, the bill requires schools to have electronic recording equipment in each designated special education classroom, seclusion area, sensory room, and time-out area not later than January 1, 2025. It also requires electronic recording equipment to be active and recording when certain areas are in use and requires school corporations to employ at least one behavioral interventionist not later than January 1, 2025. Language regarding cameras in classrooms remains a big concern.

HB 1380 - Various Education Matters, Regarding Special Education Due Process Hearings

Passed the House 91-7 and moves to the Senate. This bill provides that schools have the burden of proof rather than a parent in due process hearings. It also provides that parents do not have to enter into a nondisclosure or non-disparagement agreement as part of a resolution of a due process hearing or a dispute. HB 1073 and HB 1380 now go to the Senate.

Legislative Priorities

Following is the status of additional legislative priorities that we will continue to focus on in the second half of the legislative session. All House bills now move to the Senate.

House Bill 1156 - Report on Medicaid Behavior Analysis Services

Requires the Family and Social Services Administration (FSSA) to prepare and submit a report to specified entities concerning data on the provision of applied behavior analysis services in the Medicaid program.

House Bill 1067 - IDD Task Force

Requires the task force for individuals with intellectual and other developmental disabilities to establish a subcommittee to make recommendations to the task force regarding the Medicaid buy-in program and benefit related barriers to employment for individuals with intellectual and developmental disabilities. Changes the expiration date of the task force from December 31, 2025, to December 31, 2024.

House Bill 1187 - Special Service Review Team and Emergency Placement

Establishes the special service review team to review denied applications and applications for which a determination has not been made for the community integration and habilitation waiver. Makes changes to the situations in which an emergency placement priority may be provided for individuals under a Medicaid waiver.

IU Health Awards Major Grant to Expand EGTI to Riley Hospital for Children

Indiana University Health has awarded The Arc of Indiana Foundation's <u>Erskine Green Training</u> <u>Institute</u> \$487,500 over three years to create a workforce training program for individuals with disabilities at Riley Hospital for Children.

EGTI, founded in 2016 by The Arc of Indiana Foundation, provides post-secondary vocational training to people with disabilities in hospitality, food service, and healthcare in Muncie, IN. Through the Lacy Family Healthcare Program, EGTI students train for a variety of jobs onsite at IU Health Ball Memorial, including kitchen cook, nutrition services, environmental services, patient transport, and inventory distribution.



The Arc of Indiana Foundation Executive Director Andy Kirby said, "EGTI has developed a tremendous partnership with IU Health and values the work we do at Ball Memorial and the relationships we have developed with the team there. Over 30 EGTI graduates have been hired at IU Health sites across the state. We are thrilled that IU Health's faith in us will allow us to expand training to Indianapolis at Riley Hospital for Children."

Students enrolled in EGTI's program through Riley Children's will attend class, master key job skills, and gain valuable work experience through an internship at Riley. In addition to hands-on job training, students will learn critical soft skills, including workplace etiquette, teamwork, taking direction, and effective communication skills.

"This year's grants connect IU Health to additional community partners who share our desire to make a positive difference in the lives of Hoosiers. We are excited about the impact this grant will have in growing EGTI's program to train individuals with disabilities to work in the IU Health system," said IU Health President and CEO Dennis Murphy.
