## A World of Opportunity

The theme for Developmental Disabilities Awareness Month 2024 is **A World of Opportunity**—a perfect theme to reflect on the history, mission and continued work of The Arc.

The Arc of Indiana was founded in 1956 when families joined together to create opportunities for their children to live, learn, work and fully participate in their communities. Over the years families, leaders of The Arc at the local, state and national level, and self-advocates – people with disabilities who advocate for themselves – have continued to work together to grow those opportunities.

We are particularly proud of the work of The Arc Advocacy Network, which is supported by sponsors of our Circles of Support Initiative. Following are The Arc Advocacy Network's core programs and services.

### TheArc@School

The Arc of Indiana partnered with the LIDS Foundation in 2023 to provide information on special education rights and how to navigate the special education system to over 100 families through TheArc@School, an online training program. In addition, we hosted focus groups with TheArc@School participants to answer questions and dig deeper into special education issues.

### Advocacy Leadership Network

A new program of The Arc Advocacy Network is the Advocacy Leadership Network, which focuses on foundational leadership and advocacy training. It began with a core group of 12 Advocacy Leadership Fellows and expanded to over 180 participants. Advocacy Leadership Fellows completed a 12-week curriculum and led peer to peer discussions, called Good Life Groups, focused on lived experiences within Charting the LifeCourse life domains: daily life and employment, community living, social and spiritual, healthy living, safety and security, and advocacy and engagement.

### Peer to Peer Mentors

An outgrowth of the Advocacy Leadership Network is the establishment of a new peer mentor program. After completing a training program, 31 mentors were matched with 35 mentees to assist them in developing their own personal vision of a good life and how to take steps to achieve their goals.

### CCIR – Career Counseling Information and Referral

Our Career Counseling Information and Referral (CCIR) project provides information to people working in sheltered workshops at subminimum wage on employment opportunities. Providers have responded by transitioning from sheltered work to developing job training programs, raising wages to minimum wage and converting to innovative day programs. In 2023, presentations were made to over 1500 people resulting in 640 referrals for Vocational Rehabilitation services.

### Medicaid Story Telling

A grant from The Arc of the United States assisted us in developing a Medicaid Story Telling project that allowed us to work closely with self-advocates and families across Indiana to identify barriers to Medicaid and learn about the impact of Medicaid policies and practices to better focus advocacy efforts. We are pleased that we have been awarded a new grant to continue this important project. Learn more on page 8.



### Family Advocates

Our team of family advocates assists and guides individuals with intellectual and developmental disabilities and their families across ages, programs and services. In 2023, they assisted over 3800 people seeking information and direct advocacy on a wide range of issues, conducted 34 presentations reaching over 1200 people, and exhibited at 68 events, reaching over 29,000 people.

# Home and Community Based Supports: How They Bring Freedom—Why We Need to Expand Them

As an individual with multiple physical, psychiatric, and developmental disabilities I rely heavily on home and community based services and supports to remain as independent as possible and to continue to seek my vision for a good life. Achieving a vision for a good life is what I hope for all people with disabilities. Having, the right home and community based supports are crucial to achieve that vision.

Home and community based services let us have that vision, but it's just the beginning. It's important that we expand these services, and I will tell you why.

I have done so much with the help of home and community based services. I have attended college, have had opportunities to be less dependent on family, and have had assistance finding resources which lead to my job. I get assistance with my activities of daily living. I get the opportunity to explore the community and do things I enjoy around town, and I get to meet some great people in the process. This may sound like sunshine and rainbows, right? Nope.

I have been hindered. I have missed out on opportunities due to shortages of staff and resources. Low pay, lack of training, and other disparities make staffing difficult for providers.

Finding supports and appropriate resources that work well for individuals can be challenging. I know this from experience. I have found it difficult to find a Medicaid waiver that is a good fit. The

Aged and Disabled Waiver was not an appropriate match for me. The Family Supports Waiver, though more of an appropriate fit, limits my resources. With the Community Integration and Habilitation Waiver being an emergency waiver, I am finding it difficult to obtain. I cannot be the only individual experiencing this issue.

Another struggle individuals and families are having is being in the dark about resources. I was fortunate to have been made aware of the waivers by medical providers, but many medical providers are not aware. I was also not made aware by my educators when I was approaching transition and I feel that transition is such an important time to be made aware of these supports.

You may be wondering how we can make waves in home

and community based services and supports. It's all in coming together to use our collective voice. We need to research, talk about, and write about these issues. It's important to stay tuned, spread the word, and write to our legislators. There are a lot of up and coming changes going on in the coming months and years within the Division of Disability Rehabilitative Services (DDRS) regarding Waiver Redesign so stay informed!

Lastly, I want to share that it is important to always remind ourselves and each other that we must not sit down and be quiet, but stand strong as advocates and leaders for change.

# A World of Opportunities

"A World of Opportunities," the theme for Developmental Disabilities Awareness Month 2024, means different things to different people with intellectual and developmental disabilities (IDD).

Some share that they want the opportunity to live more independently, receive postsecondary training or go to college, and have a meaningful job. Others look forward to traveling, connecting with peers, or being able to get married without penalizing benefits. Really not so different than people without disabilities.

The Arc of Indiana is committed to all people with intellectual and developmental disabilities realizing their goals of living, learning, working and fully participating in the community of their choice. We are all about creating opportunities alongside people with IDD.

This edition of our newsletter showcases organizations and their leaders who stand with The Arc as we create those opportunities and provide critical information and advocacy to people with IDD and their families. No one can do this work alone. We are extremely fortunate to have a network of 44 chapters covering 68 counties, and members of our Circles of Support initiative, including eight in our Mission Circle, who believe and know that people with disabilities can do amazing things.

This year started off rough with the announcement of a nearly one billion Medicaid deficit and next the Family and Social Services Administration announcement that they will address the deficit in part

on the backs Indiana's most vulnerable citizens, medically fragile children, by ending the practice of allowing parents of minor children to be paid to provide crucial care.

Thanks to the commitment of our chapters and Circles of Support members, we were quickly able to produce fact sheets, webinars, and more to educate the public and educate and advocate alongside impacted families. Indiana has a nearly 3 billion dollars surplus. It is hard to understand why the state is choosing to eliminate opportunities for families to provide care for their loved one at home rather than exploring other ways to address a deficit that still has not been completely explained.

Indiana as a state has come so far in services and supports for people with disabilities over the decades but we still must push the state to go further. We need to stand together to eliminate barriers to employment and people achieving the careers they want. We need to eliminate the social security marriage penalty. We need to figure out transportation and housing issues so that people can travel and live as they want and need to. We need to expand quality home and community based services.

"A World of Opportunity" is what all people want and deserve. We pledge to continue our work to make those opportunities a reality.

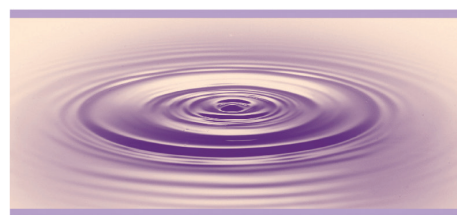

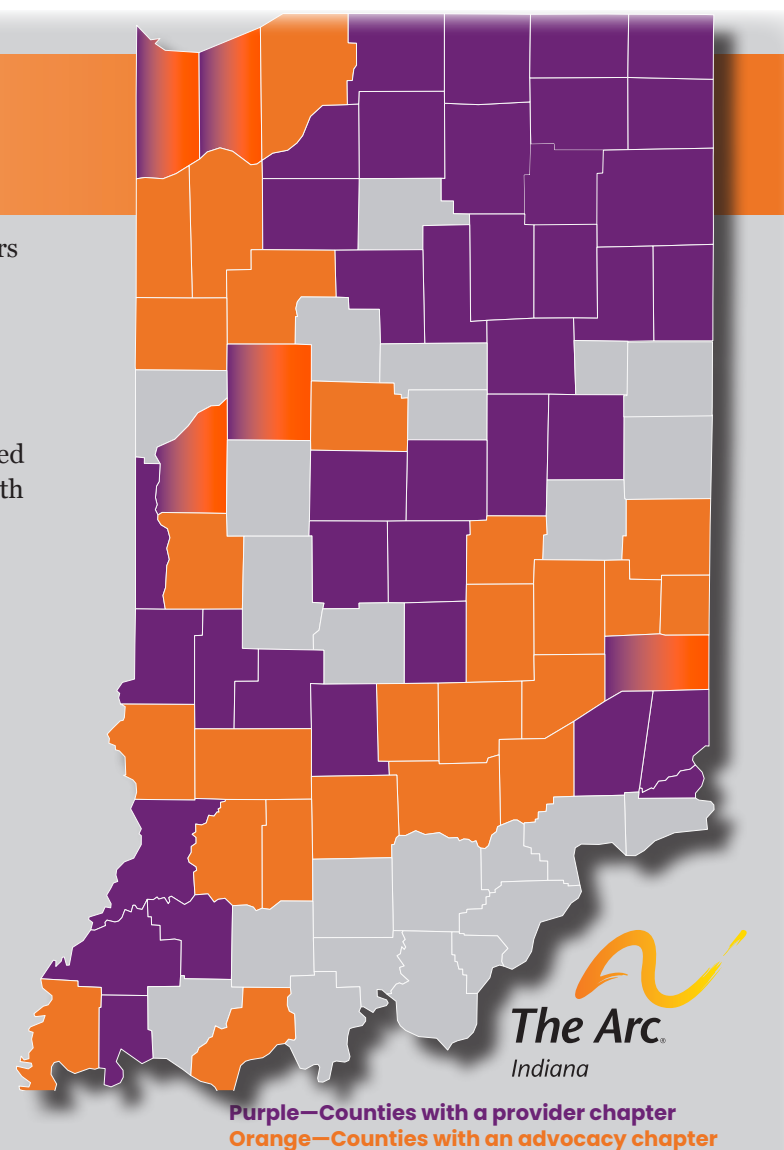

## 2024 Legislative Session Wrap-Up

The 2024 session of the Indiana General Assembly ended on March 8<sup>th</sup>. Nearly all of The Arc of Indiana's priority legislation came down to the wire in the last minutes of the session.

### Attendant Care & Structured Family Caregiving

In December 2023, the Family and Social Services Administration (FSSA) announced the state is facing a nearly one billion dollar Medicaid deficit. It came as a shock to families and advocates that they will address the deficit, in part, by ending the practice of allowing Legally Responsible Adults (LRIs) – parents of minor children and spouses – to be paid to provide attendant care to their medically fragile child or spouse. FSSA will instead only allow LRI's to be paid for structured family caregiving at a much lower reimbursement rate.

The Arc of Indiana worked alongside families and other advocates to urge legislators to address this critical issue. While we achieved significant support in the House to continue to allow LRIs to provide attendant care, and/or create an additional tier with a higher reimbursement rate within structured family caregiving, we were not able to gain support in the Senate.

We were successful in working with the House and Senate to pass HB 1102 that:

- ◆ Requires FSSA to establish a minimum percentage of the reimbursement rate paid to structured family caregiving and attendant care provider agencies that must be passed through to the person providing the service.
- ◆ Requires FSSA to report on the transition from attendant care provided by LRIs to structured family caregiving and the impact of the transition on families.
- ◆ Requires FSSA to develop a detailed plan for monitoring and projecting Medicaid expenditures with improved transparency.

We thank Representatives Ed Clere, Chris Judy, Becky Cash, Greg Porter, Cherrish Pryor, Ed DeLaney, and Lt. Governor Suzanne Crouch for their dedicated support of families on this issue throughout the session. Going forward we will closely monitor the transition and work to keep this issue in the forefront.

### Medicaid Waivers and IDD Task Force

Legislation was approved in HB 1067 to:

- ◆ Establish a special service review team to review denied applications and applications for which a determination has not been made for the Community Integration and Habilitation Waiver.
- ◆ Make changes to the criteria considered for an emergency Medicaid Waiver.
- ◆ Require the Intellectual and Developmental Disabilities (IDD) Task Force to establish a subcommittee to make recommendations regarding the Medicaid buy-in program and benefit related barriers to employment for individuals with IDD.
- ◆ Change the expiration date of the task force from December 31, 2025, to December 31, 2024.

### Seclusion and Restraint in Schools

Legislation was approved in HB 1380 to:

- ◆ Require the commission on seclusion and restraint in schools to include eliminating or minimizing the need for the use of time-out in its model restraint and seclusion plan.
- ◆ Require the commission to meet biannually (instead of annually, under current law).
- ◆ Require the commission to submit a biannual report to the state advisory council on the education of children with disabilities.

The Arc of Indiana serves on the Seclusion and Restraint Commission and will share progress on this issue.

## EGTI—Opening a World of Opportunities in Employment

The Arc of Indiana Foundation's Erskine Green Training Institute's (EGTI) mission is to provide opportunities for postsecondary vocational training for people with disabilities that empower and lead to meaningful employment.

EGTI provides vocational training for a variety of jobs in the hotel, food service, healthcare support and inventory distribution environments. We are excited to share that EGTI is expanding programing from its current

location in Muncie, Indiana to Indianapolis. Later this year, EGTI will offer training programs at Riley Children's Health and Allison Transmission.

Upon graduation, students leave with a certificate, resume, practiced interview skills and a list of open positions in their hometown. More importantly, they leave connected to the EGTI team and other resources, including an alumni group, for ongoing support and information.

Every aspect of EGTI's programming is designed to promote not only employment skills but also increased self-esteem and confidence. Over 80% of EGTI graduates have secured employment in communities throughout Indiana.

Prospective students and their families are encouraged to visit EGTI by registering for one of the monthly general tours. In addition, Career Sampling Sessions, that offer a two-

day opportunity for potential students to observe and try various jobs, are offered several times throughout the year.

### BY THE NUMBERS

#### 3,812 INDIVIDUALS & FAMILIES

The Arc Advocacy Network directly assisted 3,812 individuals & families seeking information on Medicaid, Waivers, Social Security, guardianship & alternatives, community resources, education & more.



#### 68 EVENTS, 34 PRESENTATIONS

In 2023, we conducted 34 presentations reaching over 1,200 people. We exhibited at 68 events, reaching over 29,000 people.



#### 12 FELLOWS, 180+ PARTICIPANTS

The Advocacy Leadership Network kicked off in a big way in 2023! We trained 12 Advocacy Leadership Fellows and created a network of more than 180 participants state-wide.



#### 31 MENTORS, 35 MENTEES

At the end of 2023, we launched a new peer mentoring program! So far, we've matched 35 mentees with 31 mentors, and we're just getting started.



#### 1,503 PEOPLE, 640 VR REFERRALS

In partnership with Voc Rehab, we presented at sheltered workshops across the state to provide resources about Competitive Integrated Employment to 1,503 people - resulting in 640 referrals!
